### **SCONUL needs your 'Future of the Systems Librarian' Job Descriptions!**

SCONUL is building an Organisational Development Knowledge Base which will act as repository allowing our member institutions to share and compare information about organisational structures and roles. This will be helpful for libraries when creating new posts or refreshing job descriptions and when looking for good practice in specific areas, for example, making JDs more inclusive. The Knowledge Base will be open to staff from across the institution who will also be able to review how their own role compares with others doing similar jobs. We have begun the process of building the database and are seeking some test data to populate it which will allow us to test its functionality including search functionality. Thanks to the work of the Future of the systems librarian CIG and the project group, we have a detailed understanding of variations in the role, including titles and scope, which will make this the ideal test case for development of the knowledge base. ### **Walking away: what happens next?**

With negotiations with five of the largest academic publishers coming up in 2025 and continuing concern about the value for money and ethics of the "big deals", many SCONUL member institutions will be considering their options and strategic approach. If the publishers do not recognise the need for reform and the challenging financial situation facing UK HE, many institutions will of course consider walking away. What happens within an institution in the run-up to making this decision, and what happens next? On 7 March SCONUL held a webinar, under Chatham House Rules, exploring these questions. ### **Reclaiming Academic Publishing: The Launch of the Open Journals Collective**

The Open Journals Collective (OJC), an equitable, sustainable, community-led alternative to the big deals and transformative agreements offered by corporate academic publishers, was launched on 31 March. The OJC is a collective of libraries and university-based publishers working to change the way academic research is supported and disseminated. Drawing on more than a decade of digital publishing innovation, the OJC confronts the crisis in academic journal publishing with a viable path toward bringing publishing back in-house at universities. They will launch a large collection of hundreds of diamond open access journals in the humanities and social sciences in January 2026. The [OJC Library Board](#) includes library directors, intellectual property specialists, and open research leaders. Publishers that have already joined the OJC include the Open Library of Humanities, LSE Press, UCL Press, the University of Michigan Press, the California Digital Library, and Edinburgh Diamond at the University of Edinburgh – with more publishers joining soon. ### **Dialogues on AI: Opportunities, Challenges, and Innovations in tertiary education**

Jisc are running a series of in person roundtables to bring together individuals with either a role in or strong area of interest in key issues in AI. The aim is to have a lively discussion and gain an understanding of the concerns, challenges, opportunities, and the innovations that are happening across institutions. Jisc aims to publish a position statement that encapsulates the collective insights and agreements on the topics discussed.
